**DIRECTIONS FOR USE:**

**This product must be used in accordance to the following directions by HVACR professionals only.**

1. Goggles and gloves are recommended.
2. If diluting product, utilize any of the Nu-Calgon sprayers. If using concentrated, use directly from this bottle.
3. For light soils or general cleaning, mix 10 parts water to 1 part Green Clean. For fabric and vinyl upholstery mix with 30 parts water. For linoleum, floor tile, no wax floors and general carpet cleaning, mix with 50 parts water. For glass windows, mirrors, stainless steel, mix with 150 parts water (about 1/4 oz. Green Clean in one quart of water). For more stubborn deposits, use Green Clean directly from the bottle. When using the Green Clean undiluted, apply water to surface or fabric first. Spray cleaning solution onto dirty surfaces and allow it to remain in contact for several minutes. Rinse surface thoroughly or wipe surface with a clean, damp cloth.
4. When container is empty, rinse, replace cap and dispose of properly.
