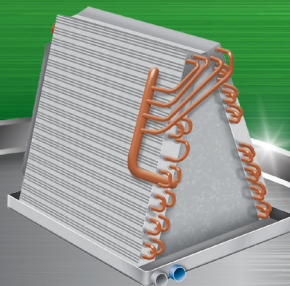

DIRECTIONS:

For use by HVACR professionals only:



Turn off or disconnect unit power and clear away heavy dirt from the coil.



Wear goggles, gloves and other protective garments. Mix Evap Pow'r-C cleaning solution according to dilution chart and apply to coil.



Wait 5-10 minutes before rinsing coil.



Evaporator – No rinse if condensation is available.
All other applications – Rinse with potable water.



For heavy soils, repeat application if necessary.



Return unit to operation.
